## **RE: SUPPORT FOR SB 347**

Dear Senator Jackson:

On behalf of Youth ALIVE!, a violence prevention and intervention program, I write to express support for Senate Bill 347. Working with the survivors of gun violence and the families of those lost to gun violence, Youth ALIVE! is acutely aware of the disastrous impact guns have in California. SB 347 will strengthen our gun laws by adding to the list of person prohibited from purchasing firearms for a 10-year period to include those convicted of specified firearm-related misdemeanors.

Studies have shown that handgun purchasers who have had a single prior conviction for a nonviolent firearm-related offense are seven times as likely to be charged with new nonviolent firearm offenses, four time as likely to be charged with new violent offenses, and five time as likely to be charged with murder, rape, robbery, or aggravated assault than a person with no prior convictions.

This bill would add the dealing handguns without a license, supplying ammunition to a prohibited person, and bringing or carrying ammunition onto school grounds, among other misdemeanors, to the 10-year-ban on purchasing firearms prohibited persons' list.

I support SB 347 Firearms: Prohibited Persons; it will help make California safer.
